
AFFIDAVIT

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On 01/27/23, In Clear Lake, Cerro Gordo County Iowa, the above defendant committed Invasion of Privacy for the purpose of arousing or gratifying a sexual desire, an aggravated misdemeanor. The above defendant used a chair to place his cell phone on top of an 8 ft wall separating adjacent tanning bed rooms. The defendant placed the phone on the edge of the wall so his camera was facing the adjacent room where a female was tanning. The female victim did not know they were being filmed and did not consent to be filmed while undressing, tanning and redressing. During the incident, the above defendant would not show law enforcement his video or photos on his phone and resisted the seizure of the cell phone.
